Who We Are



Financial Inclusion for All

The Bank On movement, led by national non-profit Cities for Financial Empowerment Fund (CFE Fund), works to ensure that everyone has access to safe, affordable, mainstream financial products and services that meet the Bank On National Account Standards. The Standards serve as a benchmark for local government leaders, community organizations, financial institutions and others for safe, affordable, transactional checking accounts. First Federal Lakewood is one of the 425+banks and credit unions across the country that offers Bank On certified accounts.

The First Federal Lakewood Access Checking Account is a no-cost certified retail checking account that features a free debit card, free Online and Mobile Banking, free monthly statements and no overdraft fees. This special product is made available on a referral basis with



clients from Burten Bell Carr Development, Northwest Neighborhoods, Towards Employment, May Dugan and The Edna House. These unbanked and underbanked community members benefit from having an opportunity to open an account without the worry of fees. We are proud to provide a product that helps customers reenter the banking sector and avoid being taken advantage of by predatory practices like check-cashing businesses.



Welcome Home with First Federal Lakewood

Promoting and supporting affordable housing initiatives is a focus for First Federal Lakewood. We partner with community development corporations and nonprofit organizations providing monetary assistance through sponsorship dollars to support critical programming. In addition to the financial and educational resources we provide to help those in need of affordable housing, special products and programs are often created to fill a gap that makes the difference between owning a home or not.



Affordable Housing Partner Spotlights

NID Housing Agency

For the past six years, First Federal Lakewood has maintained a partnership with NID Housing



Agency. The organization's focus is to provide financial literacy and economic empowerment to inner city communities. In addition, the HUD-approved credit counselors provide credit counseling pre- and post-purchase to mortgage applicants who need assistance with credit and/or financial literacy classes to qualify for downpayment assistance.

First Suburbs Consortium Development Council

First Federal Lakewood provided a grant that has covered two years (2022/2023) of the work being done by the Single-Family Zoning Analysis and Update Initiative to help



inner ring suburb communities remove the blight of empty lots and allow developers to build affordable housing (infill housing) for families. Our contribution closed the gap to get the project fully funded.

Burten Bell Carr

Burten Bell Carr (BBC) is a nonprofit community development organization that has been empowering residents and revitalizing underserved communities in Cleveland Central Kinsman neighborhoods since 1990. BBC works to revitalize neighborhoods by transforming vacant and under-utilized land into new housing, retail/commercial, mixed-use and greenspace developments.

First Federal Lakewood created a special lending product called Pathways



to Homeownership as part of our partnership with BBC to assist those who are leasing homes with an option to buy. The loan product offers flexible underwriting and reduced closing costs.



(Financial) Knowledge is Power

Teaming up with EVERFI to Bring Financial Education to the Classroom

EVERFI teaches learners about financial skills they will need to master as they transition to adulthood, from navigating the banking system to long-range concepts like credit, debt and insurance.

I love how this course teaches you the smartest and most efficient way to take care of your money. Also, EVERFI helps me understand the risks of what would happen if you didn't take care of your debts, loans and spending of your money. EVERFI provides digital lessons for K-12 students that prepare them for career and life success. Teachers are equipped to use EVERFI's standard-aligned, research-based digital lessons to teach students to thrive in an ever-changing world through financial education. As part of the program, the students complete a pre- and post-assessment to see how much knowledge is gained. After participating in EVERFI, more students report that they feel at least somewhat prepared to take on tasks like setting up and following a budget so that they can manage spending and saving over time.

Working Together for a Brighter Future

Workforce development is crucial to building and sustaining thriving communities now and for generations to come. These efforts and outreach are not one-size-fits-all because every jobseeker is unique and has their own story. Some are students working toward their first job, some are re-entering the work force after struggling with issues like addiction or homelessness, and some are trying to break into a new career.

Just like First Federal Lakewood supports a diverse customer base with an endless variety of financial needs and goals, we support all kinds of people striving for their career goals.

The Edna House

Located near our Gordon Square branch, The Edna House has assisted women in recovery



from substance abuse for almost 20 years and serves an average of 75 women per year. We proudly partner with The Edna House for the second part of their 10-week program, which focuses on job skills training and financial literacy after the women achieve sobriety.

The seminars help build money management skills for women in the program who will be re-entering the workforce. From budgeting and opening a savings or checking account to resume writing and interview skills, we are dedicated to setting the women up for success once they leave the Edna House. In 2023, First Federal Lakewood conducted 15 seminars at the Edna House and sponsored their Annual Recovery Run 5k fundraiser event.

Towards Employment

Towards Employment connects individuals to careers where they can advance in life. They serve communities



throughout Northeast Ohio with a mission to empower individuals to achieve and maintain self-sufficiency through employment.

As a recruiter, I focus on the mock interview portion of the wide variety of services that Towards Employment provides to those looking to get back into or move within the workforce."

"Although, if someone is interested in a role in banking, it's even more of a full-circle opportunity to assist them by sharing information about First Federal Lakewood and our mutual mission. This type of work is important to show our neighbors that we care and want to see them succeed wherever they are in life."

In addition to offering Towards Employment program participants the Access Checking Account as part of the Bank On initiative, First Federal Lakewood focuses the partnership on job interview practice. Employees volunteer twice each month to prepare the individuals by doing mock interviews, giving feedback and tips for a successful interview with a potential employer. Also, we sponsored their 2023 annual A Chance to Advance Gala that raises funds to support essential programing.



Youth Opportunities Unlimited

For more than 40 years, the nonprofit Youth Opportunities Unlimited (Y.O.U.) has served



teens and young adults between the ages of 14 and 24 who live in underserved areas throughout Northeast Ohio. Their mission is to prepare participants to become economically self-sufficient contributors to building Northeast Ohio's educated, skilled and inclusive workforce.

We work closely with Y.O.U. by providing financial literacy classes focused on budgeting and credit, as well as resume writing workshops and mock interviews. Every spring, Y.O.U. hosts their Youth Career Olympics where students compete to showcase the skills and knowledge they have learned through the school year. In addition to sponsoring the organization's programming and Olympics, our employees volunteer to coach students throughout the year in preparation for their Olympics.

First Federal Lakewood's dedication goes beyond financial support — their employees actively engage with our youth, volunteering their time and expertise to make a meaningful impact."

Small Businesses are the Fabric of Our Community

When it comes to applying for a business loan, fast approval and ease are top of mind for many business owners. As a proud Preferred Small Business Association (SBA) lender, we are committed to helping community members start, run and grow their businesses. After a thorough review process, the SBA designates special status to select banks called Preferred Lender. This means the bank takes the approval process in-house, among other operational steps, instead of delegating it to the SBA.

First Federal Lakewood earning SBA Preferred Lender status in December 2022 is one way we help small businesses by providing the funds they need to grow."

2BEngineering Spotlight

2BEngineering (2BE) is a woman-owned consulting engineering firm located in Cuyahoga Falls. Its focus is 2B

designing mechanical and plumbing systems (creating blueprints) for commercial renovation projects and new buildings. Established in 2021 by Madison Morgan, the firm began with one Engineer and has tripled in engineering capacity since its founding.

By late 2022, 2BE was ready to expand into a physical office space for client meetings and enhanced team collaboration, and Madison had her eye on a local building for sale. Her real estate journey began by requesting a loan from multiple banks, most of which deemed her unqualified due to a common issue new small businesses face — lack of a large volume of business tax returns.

Madison met with Matt Lay, Relationship Manager and Small Business Banking Leader, to learn about our SBA loans and assist in accomplishing her growth goals. First Federal Lakewood is proud to have approved Madison for the SBA loan she would go on to use for renovating and branding her new building.

Since securing the loan, the 2BE team has increased to three Engineers, an office coordinator, a college and high school intern.

The connectivity between 2BE and First Federal Lakewood is an inspiring example of how mutual banks help community members achieve their dreams of growing a business so that business can pay it forward by providing opportunities to help others succeed.

Although she is a young entrepreneur and 2BE is only three years old, Madison already dedicates herself to giving back to her community and industry. Beyond hiring interns at different points in their career paths, she volunteers with the Akron chapter of the American Society of Heating, Refrigeration and Air-Conditioning Engineers (ASHRAE) and participates in mentorship events through the ACE (Architecture, Construction, Engineering) Mentor program.

"2BE is a service business with direct involvement in our community," said Madison Morgan, Owner and Principal Engineer at 2BEngineering. "We can drive around and point out buildings that we played a role in designing."

Spotlight on Habitat for Humanity

Greater Cleveland Habitat for Humanity (GCHFH) was founded in 1987 with a vision to revitalize Cuyahoga County neighborhoods and help local hard-working, low-income families help themselves create strength, stability and self-reliance. They build, rehab and sell homes to families with an affordable mortgage while connecting them to the community through neighborhood revitalization projects.

Volunteering is just one way First Federal Lakewood supports GCHFH. Team members participate in home restoration projects that include tasks such as painting, hanging drywall and repairing porches. As in previous years, a team of employees participated in the annual Habitat for Humanity Walk, Run and Mosey fundraising walk. Not only did First Federal Lakewood



provide funding through sponsorship, but team members personally raised funds on their own.

We also partner with GCHFH by acting as their bank for their participation in the Federal Home Loan Bank of Cincinnati Affordable Housing Program. This program allows them to receive additional funding.
